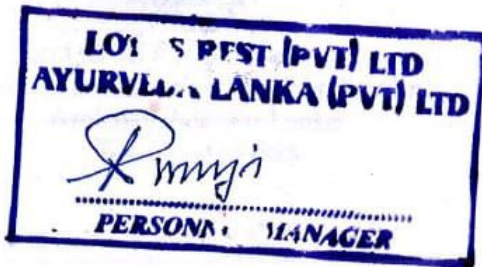

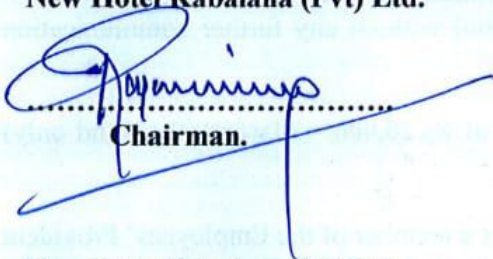
We have pleasure in appointing you to the post in **Laundryman** for the above Company, on the following terms and conditions.
